Terms and Conditions

1. **Purpose:** This agreement is between Heirloom Family Memories, 28118 Sycamore Court, Magnolia, Texas 77355, (hereinafter “We”) and the purchasers of videography services (hereinafter “You”).
2. **Description of Services:** We will provide videography coverage for your wedding day. The raw footage will then be edited and delivered to you on a DVD or BRD. The edited disc will generally be about one hour, depending on the selected Package, add-on items, and artistic considerations.
3. **Price:** The price for videography services are as given in the Payments section of the Agreement.
4. **Payments:** You shall make payments according to the payment schedule in the Agreement. The total cost of the Package is divided into three payments. The first payment is due at the time of signing this document, the second payment is due 60 days prior to the wedding, and the last payment is due 30 days prior to the wedding. We reserve this date and time exclusively for you. **For this reason, all retainers and payments are non-refundable, even if the wedding date is changed or canceled for any reason.** No services will be rendered, or products will be delivered when a balance is overdue.
5. **Copyright and Reproductions:** We shall own the copyrights of all images created and shall have the exclusive right to make reproductions for promotions, advertising, competition, and exhibitions.
6. **Customization:** All customization requests, including media (pictures, music, video, film, etc.), must be provided on or before the wedding day. There will be a \$125 additional charge for any such requests after the wedding, in addition to any other charges or expenses incurred to carry out the request.
7. **Accidents & Malfunctions:** We take extreme care to create high quality products, but we are not responsible for damages caused by acts of God, accidents and/or defective materials or equipment utilized in good faith by us; or if any or all of the images are lost, stolen, damaged, and/or destroyed for any reason whatsoever. The discs produced are state of the art technology, and may not be compatible with older players.
8. **Liability:** Our maximum liability is limited to the return of all payments received for the event package. Should the term of this contract not be met due to illness, accident, emergency, or any other reason the maximum liability shall be limited to the amount paid by you. Your satisfaction is important to us. However, we do not make any warranties or guarantees, either implied or expressed, to any particular image or sound, or to meet any particular aesthetic criteria or standards as part of its performance under this contract. You specifically agree that the maximum liability under ANY circumstances for us shall be limited to the amount paid.
9. **Arbitration:** Your satisfaction with us and the quality of our products are very important to us. The parties agree that disputes shall be submitted to the Arbitration and Mediation Associates of Houston, Texas, whose decision shall be binding upon the parties as the sole and exclusive remedy to resolve any disputes.
10. **Overtime:** We will arrive and stay as long as it takes to produce a quality product for you. Please try to limit our overtime. At our discretion, overtime may incur a charge of \$145 per hour.
11. **Re-editing:** Requests for changes to the final edited disc will be subject to \$125 per hour (SD) or \$150 per hour (HD). An estimate will be given, and the editing will commence upon payment of estimate.
12. **Meals & Parking:** Please provide the videographer(s) with meals and parking at no charge.
13. **Agreement:** You warrant that you have read the Agreement prior to its execution (signing) and are fully familiar with its contents. This agreement incorporates the entire understanding of the parties, specifically excluding any verbal or written representations that are not contained in this agreement; any modification of this Agreement must be in writing and agreed upon by all parties.
